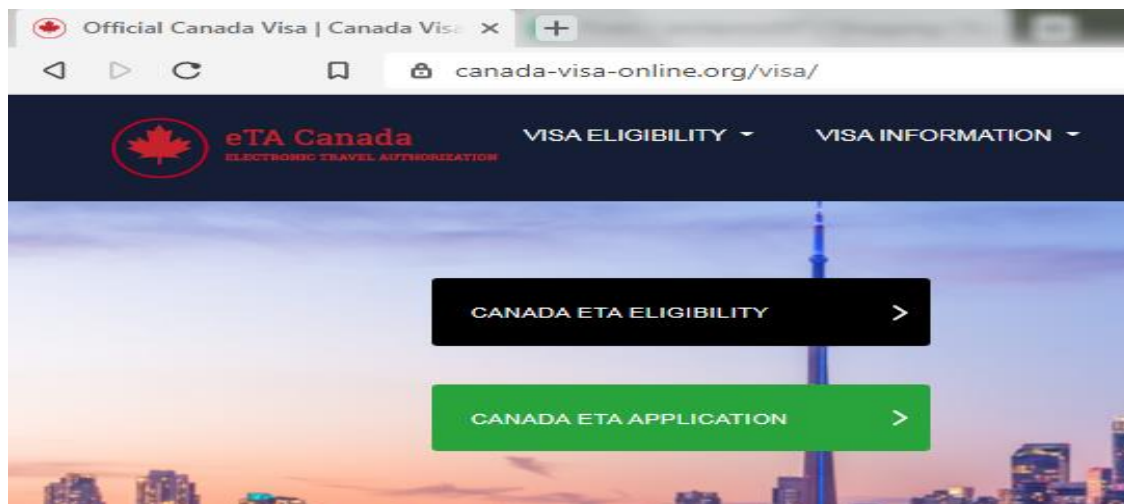


The application process for a Canadian visa just became a whole lot easier!
