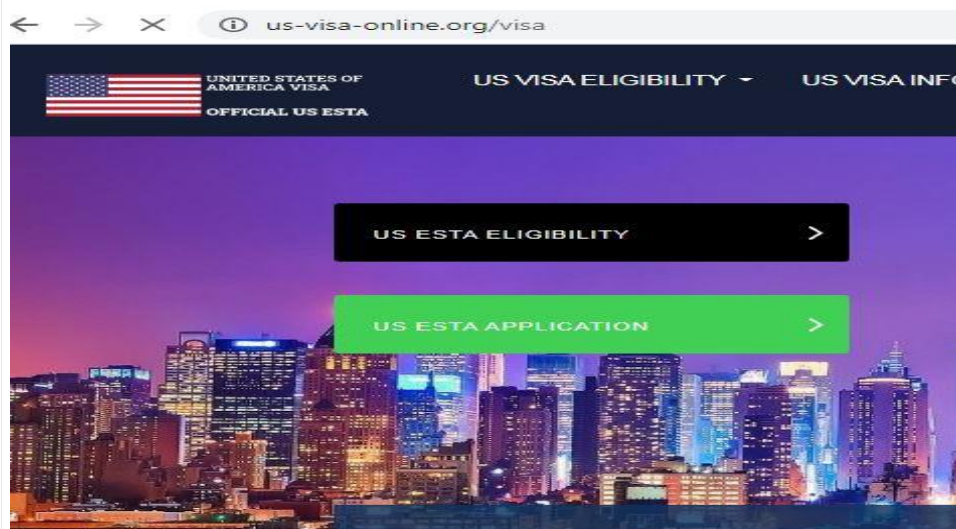


Apply for Your US Visa Online in Five Easy Steps!
